Payment Date	On <b>22nd of April</b> , <b>2022</b> , dividends will be paid electronically to shareholders ("Qualifying Shareholders") whose names appear on the Register of Members as at <b>9</b> <sup>th</sup> <b>of March</b> , <b>2022</b> , and who have completed the e-dividend registration and mandated the Registrar to pay their dividends directly into their Bank accounts.
Election for Scrip Dividend Instead of Cash Dividend	The Directors are also recommending to Shareholders for their approval at the forthcoming AGM, a right of election for Qualifying Shareholders to receive <b>new ordinary shares</b> in the Company instead of the <b>final dividend in cash</b> . The election is required to be made on or before the <b>12</b> <sup>th</sup> <b>of April, 2022</b> . The Reference Share Price for the purpose of determining the number of shares due to Qualifying Shareholders who elect for the share option will be a ten-day trading average of the Company's share price on the floor of the Nigerian Exchange Limited, starting on the <b>10</b> <sup>th</sup> <b>of March, 2022</b> .
