# **Proof of Consent**

### 1. Introduction

Our website, <a href="https://www.nbplc.com">https://www.nbplc.com</a> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). ### 2. What are cookies?

#### 5.1 Technical or functional cookies

#### 5.4 Social media


